- Applications must be received 60 days prior to the intended event date. All show applications turned in under 60 days will not be accepted.
- Shows will not be posted until fees are paid and a completed show application has been received. Within 60 Days of the event we must have a copy of the venue contract, 30 days from event date we must have insurance certificate, all judges and rep agreements completed and signed by both parties. If these are not received the show will be taken off the website and will be deemed non sanctioned by the IOEBA.
- I understand IOEBA has the right to refuse or revoke any dog registration as deemed necessary.

Fees: Initial _____

Applicable Application Fees (due at time of application submission):

- \$100.00 - fee to host a single IOEBA Show
- \$150.00 - fee to host a double IOEBA Show
- \$200.00 - fee to host a triple IOEBA Show
- \$50.00 - fee to host each additional IOEBA Show
- We recommend hosting a maximum of two sanctioned conformation shows per day and four sanctioned conformation shows over a two day period.

- More then three sanctioned conformation shows per day will not be allowed
